The Welsh Language Commissioner's initial comments on Coleg Gwent's applications

1. Standards challenged in a particular way:

Standard 55

You must ensure that -

- (a) the text of each page of your website is available in Welsh,
- (b) every Welsh language page on your website is fully functional, and
- (c) the Welsh language is not treated less favourably than the English language on your website.

Imposition day: 01/10/2019

Standard 58

If you have a Welsh language web page that corresponds to an English language web page, you must state clearly on the English language web page that the page is also available in Welsh, and you must provide a direct link to the Welsh page on the corresponding English page.

Imposition day: 01/10/2019

Standard 59

You must provide the interface and menus on every page of your website in Welsh.

Imposition day: 01/10/2019

Summary of the application

- 1.1. You claim that the requirement to comply with standards 55, 58 and 59 is disproportionate in the way in which they were imposed, specifically the imposition date, and seek to extend the imposition date to 16 December 2019.
- 1.2. This extension would enable you to complete the remaining work required to adapt the website and incorporate the delay incurred by the organisational restructure.
- 1.3. You note that it is possible you will be compliant with these duties before the imposition date sought.
- 1.4. In light of the above, my proposed decision is that the requirement to comply with standards 55, 58 and 59 as imposed is disproportionate.
- 1.5. The Commissioner agrees to vary Coleg Gwent's compliance notice by extending the imposition date for these three standards to 16 December 2019.
- 1.6. Please confirm whether you agree to the above circumstance so that further consultation is not needed in the case of these standards.
